In 2020, KAC in partnership with KAC National chapters executed a "GET OUT THE VOTE" campaign and created a series of culturally sensitive videos to encourage early voter registration and educate Korean American voters on safe voting methods, ballot measures, and LA County's new voting system.

KAC also collaborated with the League of Women Voters for the Korean version of the LWV Easy Voter Guide. ED Eunice Song was a Trusted Voices Spokesperson for the Voter Engagement Radio Campaign for the November 2020 General Election.

The November 2020 Korean Language ballots and voter guides were delivered several weeks ahead of the election for the first time and were error-free thanks to our advocacy efforts.

KAC worked closely with the LA County Registrar to lead an advocacy initiative that ensured prompt distribution of accurate Korean ballots for the November 2020 election - addressing 1,098 erroneous Korean-language sample ballots distributed for the March 2020 primary election. KAC's early and continued involvement for the current November 2020 ballots contributed to ensuring that the ballots' Korean language information was correctly conveyed for voters to make informed decisions.



For the 2022 primary election, we had to advocate for Chinatown and Koreatown because there were no vote centers in either community. KAC took the lead in mobilizing civic engagement nonprofits: AJSOCAL, CAUSE, and AAPI Equity Alliance and successfully helped the LA County Registrar's office secure more voting centers – some of which became 11-day vote centers in the General Election in November. This impacted the hundreds of thousands of eligible voters in LA County.



In 2022, we continued to provide drop-in assistance, phone banking, and physical drives - from May AAPI LA Day Event to September Los Angeles Korean American Festival. During the November 2022 general election, KAC has assisted over 10,000 community members to cast their ballots.



COVID-19 COMMUNITY SUPPORT



Since March 2020, the KAC team has been working tirelessly to serve the Korean American community by providing in-language COVID-19 resources, providing PPEs, and by assisting our constituents during the pandemic.

While it is difficult to capture how extensive the impact will be for Korean American community due to COVID-19, our organization is on the frontlines and we have seen

a significant increase in call volume for issues related to COVID-19 resources such as EDD Unemployment benefits, SBA Loans, Stimulus Checks, Public Health and Safety information, and more.

KAC STANDS AGAINST ASIAN HATE

In addition to expanding our services to address community needs exacerbated by the pandemic, we pursued our vision by defending our communities against Asian Hate crime. KAC in partnership with AAPI Partner Organizations including AAPI EQUITY ALLIANCE (formerly known as A3PCON) and Advancing Justice Southern California (AJSOCAL) supports our community members who are facing hate and violence as well as help them to report hate crimes and incidents.

In 2022, KAC collaborated with the Los Angeles City Attorney's office to share the importance of reporting hate crimes and incidents. Deputy City Attorney Daniel Lee and KAC Executive Director Eunice Song talked about the importance of reporting, highlighting available victim support and resources.

BYSTANDER INTERVENTION TRAINING IN KOREAN

Since Fall of 2021, in collaboration with the Asian Americans Advancing Justice Southern California (AJSOCAL) and Right To Be (formerly, Hollaback!), KAC has been providing free online in-language bystander intervention training focused on promoting awareness and teaching how bystanders can intervene safely. Starting in 2023, KAC successfully launched a new, on-site, in-person bystander intervention training in Korean.







IN-PERSON BYSTANDER TRAINING



On January 27th, 2023, KAC conducted a one-hour in person bystander intervention training in Korean at the Korean American United Foundation Community Hall.

48 community members participated in the training and learned about the history of discrimination, discussed the types of disrespect that the Asian community is facing, and practiced the

5-D methodology on how to safely intervene when witnessing hate and harassment in public spaces. The audience consisted of seniors with limited English proficiency, actively engaging throughout the training by sharing their experiences, participating in practice scenarios, and calling for more opportunities for in-language training and resources.

MONTHLY FREE LEGAL CLINIC & COMMUNITY EDUCATIONAL WEBINAR SERIES

Recognizing the significant barriers to accessing resources faced by community members with limited English proficiency, KAC joined forces with the Korean American Bar Association of Southern California (KABA-SoCal), Advancing Justice Southern California (AJSOCAL), and the Consulate General of the Republic of Korea in Los Angeles (KCG) to offer monthly educational webinars and free 1:1 consultations every third Wednesday from 12-1 PM (known as the "Monthly Legal Clinic", "월간법률상담소" in Korean), providing muchneeded support and resources in-language for the Korean community.





ALTERNATIVE DISPUTE RESOLUTION

In 1997, the KAC Alternative Dispute Resolution Center (4.29 Center) was founded in response to the ethnic upheaval that devastated parts of Los Angeles during the 1992 Los Angeles Riots. The Center provides culturally sensitive and efficient means of resolving disputes between parties without recourse to the court system. During the pandemic, the 4.29 Center pivoted to providing online, virtual mediation and conciliation services as well as providing in-language resources via our ad hoc hotline to help community members timely access to pandemic-essential resources.

COALITION BUILDING WITH DIVERSE GROUPS



KAC continues to help build leaders through strengthening coalitions with diverse groups. In the wake of the 30th anniversary of the 1992 LA riots, on April 29, 2022, KAC in collaboration with five other L.A.-based organizations (Korean American Federation of Los Angeles, Koreatown Youth and Community Center, Asian Americans Advancing Justice Southern California, the First African Methodist Episcopal Church, and the Los Angeles Urban League), jointly hosted L.A. Uprising: Saigu Peace Gathering to contemplate the 30th anniversary of the Los Angeles Riots and foster collective healing, coalition, and unity between the Asian and African American communities ("Event").

To draw in younger generation audiences who don't learn much about the event in school, community leaders brought together young Asian and African American artists, hoping to educate young people from both groups about a turning point in the city's history and to reflect on the ongoing work of healing past wounds and building trust. Hundreds of community members came together for this peaceful Event to commemorate the 30th anniversary of L.A. Riots.
